2. The Government of Tanzania has set aside funds for the operation of the Reli Assets Holding Company Limited (RAHCO) during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **hiring of Earth Moving Equipments for Track repair and drainage improvement along Kilosa-Gulwe section**

5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary Tender Board, Ground Floor; Sokoine Drive/Railway Street, Dar es Salaam** from 10:00am to 4:00pm on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Documents in English language and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of Tanzanian shillings **100,000/=**. Payment should either be by Cash, Banker’s Draft, or Banker’s Cheque, payable to Reli Assets Holding Company Limited, P.O Box 76959, Dar es Salaam.
7. All Tenders must be accompanied by a Tender Security **in the form of Bank Guarantee** in an acceptable form in the amount of **Two (2) Percent** of bid price or freely convertible currencies in case of foreign Tenderers
